### **My Account**

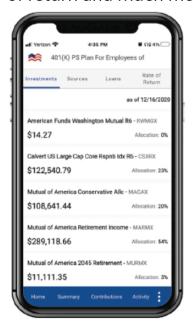
Participants can take control of their retirement accounts and their investment strategy using the My Account portal.
